In the quest for continuous improvement of the harmonised programme and to reduce the response burden of managers and consumers, DG ECFIN, together with its partners, carried out a conceptual and analytical screening of all questions in the current questionnaires and decided to cease the release of some answers to questions that could be redundant or of limited added value for the user.

As a result, starting in July 2024, the update of the related time series of specific questions listed below is suspended.

Service survey:

1. Monthly question "Evolution of employment over the past 3 months" (Question 4)

Consumer survey:

2. Monthly question "In view of the current economic situation, is it a good moment to save" (Question Q10)
3. Quarterly question "Intention to buy a car within the next 12 months" (Question Q13)

Industry survey:

Quarterly questions

1. "Number of months of production assured by current overall order books" (Question 10)
2. "Export order developments in the next three months" (Question 12)
3. "Competitive position over the past 3 months: on the domestic market" (Question 14)

Construction survey:

4. Quarterly question "number of months' work accounted for by work in hand and work already contracted for" (Question 6)

Those questions do not impact neither on the computation of the confidence indicators nor on the ESI.
