on the financing of the Pericles IV programme and the adoption of the annual work programme for 2021

1. Introduction

This work programme contains the actions to be financed. The distribution of budget and the main actions are as follows:

For grants (implemented under direct management) (point 2): EUR 450 000;

For procurement (implemented under direct management) (point 3): EUR 384 082.

a) Legal basis

- Proposal for a Regulation of the European Parliament and of the Council, submitted by the Commission on 31 May 2018, establishes an exchange, assistance and training programme for the protection of the euro against counterfeiting for the period 2021-2027 (the 'Pericles IV programme') (COM(2018) 369).
- Proposal for a Council Regulation, submitted by the Commission on 31 May 2018, extending to the non-participating Member States the application of the proposal for Regulation (COM(2018) 369), establishes an exchange, assistance and training programme for the protection of the euro against counterfeiting for the period 2021-2027 (the 'Pericles IV' programme) (COM(2018)371.

b) Budget line

06 3 01 - Protection of the Euro against counterfeiting

c) Objectives pursued

<u>General objective¹</u>

To prevent and combat counterfeiting and related fraud, preserve the integrity of the euro banknotes and coins, thus strengthening the trust of citizens and business in the genuineness of these banknotes and coins and therefore enhancing the trust the Union's economy, while securing the sustainability of public finances.

<u>Specific objective²</u>:

To protect euro banknotes and coins against counterfeiting and related fraud, by supporting and supplementing the measures undertaken by the Member States and assisting the competent national and Union authorities in their efforts to develop among themselves and with the Commission a close and regular cooperation and an exchange of best practice, where appropriate including third countries and international organisations.

Priorities of the Pericles IV strategy for 2021:

The priorities on which the Pericles Programme is based in 2021 are listed in the update of

the Pericles Strategy 2021³.

They have been endorsed by the Euro Counterfeiting Experts Group (ECEG), as provided for by Council Regulation (EC) 1338/2001 of 28 June 2001.

They are as follows:

- a. Supporting activities aimed at improving cooperation among those Member States which are particularly affected by the production and distribution of counterfeits
- b. Fostering cooperation with authorities of third countries where there is suspicion of or evidence for counterfeit euro production
- c. Maintaining an efficient framework for the protection of the euro in South Eastern Europe
- d. Topical developments:
 - I. Security features of euro coins
 - II. Distribution of counterfeits and high quality components on the darknet, and 'movie money' and 'prop copy' products online (including altered design notes)
 - III. The Implementation of Regulation (EU) No 1210/2010 concerning authentication of euro coins and handling of euro coins unfit for circulation
 - IV. Support for the establishment / reinforcement of NCO's

d) Expected results

- higher capacity of the national experts to address issues related to counterfeiting of the euro;
- strengthening of the cooperation and exchange of information between competent national authorities in relation to the protection of the euro against counterfeiting, both inside and outside the EU;
- improve knowledge on the legislation and administrative practices concerning the protection of the euro;
- harmonisation of the administrative practices in relation to the relevant legislation in different Member States;
- improving cooperation within the European Union and improving its relations with third countries;
- strengthening the technical capacity of third country agencies to investigate euro counterfeiting.

2. Grants

The global budgetary envelope reserved in 2021 for grants under this work programme is EUR 450 000 on the Protection of the Euro against counterfeiting budget line.

a) Type of applicants

Bodies eligible for funding under the Programme shall be the competent national authorities as defined in point (b) of Article 2 of Regulation (EC) No 1338/2001.

b) Description of the activities to be funded by the grant(s) awarded under the call for proposals

The activities of the programme shall be implemented in conformity with Article 5 defining joint actions and Article 6 of Proposal (COM(2018)369) defining multidisciplinary and transnational aspects as well as target groups, and shall include the following eligible actions:

- (a) exchange and dissemination of information, in particular through organising workshops, meetings and seminars, including training, targeted placements and exchanges of staff of competent national authorities and other similar actions. (see Art. 6(1)(a) of the basic act);
- (b) technical, scientific and operational assistance, as appears necessary as part of the Programme including in particular the actions mentioned in Art. 6(1)(b) of the basic act;
- (c) grants to finance the purchase of equipment to be used by specialised anti counterfeiting authorities of third countries for protecting the euro against counterfeiting, in compliance with Art.6(1)(c) and Art.7 of the basic act.
- c) Implementation

Directly by the DG.

d) Selection criteria - Financial and operational capacity

Financial capacity:

Applicants must have stable and sufficient resources to successfully implement the projects and contribute their share.

Organisations participating in several projects must have sufficient capacity to implement all these projects.

The check will normally be done for all beneficiaries, except:

- public bodies (entities established as public body under national law, including local, regional or national authorities) or international organisations.
- if the individual requested grant amount is not more than EUR 60 000.

Operational capacity:

Applicants must have the know-how, qualifications and resources to successfully implement the projects and contribute their share (including sufficient experience in projects of comparable size and nature).

Public bodies are exempted from the operational capacity check.

e) Award criteria

Applications submitted by the applicants that fulfil the eligibility and selection criteria will be assessed on the basis of the award criteria mentioned below:

- Relevance:

- 1. Compliance with the Programme's objectives and priorities, and the level of coverage of the various target groups.
- 2. European dimension, including in particular aspects that relate to cooperation with ECB and Europol.

– Quality:

- 1. Intrinsic quality of the project in terms of conception, organisation, presentation and objectives.
- 2. Cost-effectiveness ratio.
- Impact:
 - 1. Complementarity with previous, current or future projects carried out or planned at national or European level in combating currency counterfeiting.
 - 2. Impact and anticipated results on the attainment of the Programme's objectives.
- f) Maximum rate of co-financing

The costs will be reimbursed at the funding rate fixed in the Grant Agreement (up to 75%).

Applicants can apply for a higher project funding rate (up to 90%) in exceptional and duly justified cases⁴.

Such duly justified cases include in particular:

- conferences, seminars and workshops taking place in third countries identified in priority action point b. of the Pericles IV 2021 strategy⁵ and Turkey, as referred to in priority action c. of the Pericles IV 2021 strategy;
- actions addressing priority action point d.II of the Pericles IV 2021 strategy;
- actions introduced by competent national authorities that did not apply for Pericles funding in the calendar years 2018, 2019 and 2020 in order to encourage greater participation of the competent national authorities as underlined in the Mid-Term Evaluation of the 'Pericles 2020' programme (SWD(2017)443);
- Conferences, seminars and workshops inviting at least 70 participants from at least 10 countries in order to encourage greater participation of the competent national authorities as underlined in the Mid-Term Evaluation of the 'Pericles 2020' programme (SWD(2017)443).

The global budgetary envelope reserved for procurement contracts in 2021 is EUR 384 082 on the Protection of the Euro against counterfeiting (Pericles IV programme) budget line.

The procured actions will focus on the implementation of the Pericles Strategy 2021:
