




BUSINESS AND CONSUMER SURVEY RESULTS

November 2019: Economic Sentiment slightly up in both the euro area and the EU

In November 2019, the *Economic Sentiment Indicator* (ESI) increased slightly in both the euro area (by 0.5 points to 101.3) and the EU (by 0.9 points to 100.0).¹

Euro area developments

The improvement of euro-area sentiment resulted from slight increases in confidence among consumers and retail trade managers, while confidence remained broadly unchanged in industry and services. Only confidence in construction decreased sharply. Amongst the largest euro-area economies, the ESI increased in Spain (+0.7), France and Germany (both by +0.4), while it remained virtually unchanged in Italy (-0.1) and worsened in the Netherlands (-1.0).

Broadly unchanged **industry confidence** (+0.3) resulted from managers' more optimistic *production expectations* and assessments of the *stocks of finished products*, while their assessment of the *current level of overall order books* deteriorated slightly. Of the questions not included in the confidence indicator, managers' assessment of *past production* deteriorated significantly, while their views on *export order books* remained broadly unchanged. Broadly stable **services confidence** (+0.3) was the result of improvements in managers' *demand expectations* and, to a lesser extent, views on the *past business situation*, which were offset by a fall in managers' assessment of *past demand*. The slight increase in **consumer confidence** (+0.4) reflected households' more positive expectations about both the *general economic situation* and their *future financial situation*, while their assessment of their *past financial situation* and their *intentions to make major purchases* remained (broadly) stable. The moderate improvement in **retail trade confidence** (+0.7) resulted from more positive views on both the adequacy of the *volume of stocks* and, to a lesser extent, the *expected business situation*, while the assessment of the *past business situation* was unchanged. Lower **construction confidence** (-1.3) was due to managers' more pessimistic *employment expectations* and worsened assessments of the *level of order books*. Finally, **financial services confidence** (not included in the ESI) increased markedly (+9.5), reflecting strong increases in all its three components (i.e. assessments of *past* and *expected demand* and the *past business situation*).

Employment plans worsened somewhat in construction and industry, while remaining broadly unchanged in services and retail trade. Consumers' unemployment expectations improved a little. **Selling price expectations** decreased marginally in industry and services, while remaining broadly stable in retail trade and picking up slightly in construction. Consumer price expectations dropped in November.

EU developments




The increase in the headline indicator for the EU (+0.9) was slightly more pronounced, thanks to improvements in the ESI for the UK (+1.1) and Poland (+0.7). In line with the euro area, confidence remained broadly stable in industry and improved in retail trade and among consumers. By contrast, EU confidence improved markedly in services and remained broadly stable in construction. The rise in EU financial services confidence was in line with euro-area developments.

¹ Business confidence indices for France were revised compared to the October press release; the net effect is an upward revision of the ESI for October of 0.1 points in the EU (to 99.1).

EU managers' employment expectations remained broadly stable in industry and services, while they decreased slightly in retail trade and construction. Price expectations declined in industry and services, while increasing marginally in retail trade and remaining practically unchanged in construction.

Industrial investment survey (conducted in October/November)

According to the bi-annual investment survey carried out in October/November this year, real investment in the manufacturing industry in 2019 is expected to decrease by 2% in both the euro area and the EU. Compared to the previous survey conducted in March/April this year, this represents a downward revision by 6 and 5 percentage points for the euro area and the EU, respectively. For 2020, managers expect an increase in real investment by 1% in both regions.






