Macro-modelling workshop on global and cross-country spillovers

Organized by the European Commission's Joint Research Centre and DG ECFIN. Brussels, 29-30 November, 2018.

The aim of the workshop is to share experiences in developing, estimating and using structural macro-models for policy analysis, forecasting and medium term projections. Particular focus will be put on modeling and assessing global and cross-country macro-economic spillovers. The discussion will range from issues at the global level, like the implications of big supply and demand shocks and cycles in emerging economies or the common/idiosyncratic drivers of the different recovery patterns in Europe and US; to country-specific experiences/lessons in spillovers inside the euro-area.

What is the degree of cross-country co-movements captured by our models? What can help in better characterizing them? What are the main deficiencies in the performance of our models in forecasting key international and domestic economic developments? What insight do we gain to complement more traditional macro-econometric forecasting tools?

The workshop is mostly addressed to modelers and analysts in EU policy institutions: EC, ECB, national central banks and ministries of euro-area/EU Member States. Experts on macro-econometric forecasting from academia are also welcome as presenters and discussants/panellists.
